Moreover, discourses of power differ between the professional and private contexts. While the athletes expect their coaches to exert dominance and control in the elite-sport context, love relationships are about equally and mutually giving away power and control. Although CASR can facilitate motivation and performance, framing CASR as inherently unequal and abusive can contribute to stigmatisation, secrecy and athlete disempowerment.

By this rule, a 1,500-mg/m2 dose of cyclophosphamide in an older child could be converted to a dose of 50 mg/kg in a younger child.
