## **CONFLICT OF INTEREST MANAGEMENT POLICY**

### **THE POLICY**

**What is conflict of interest policy for management?** A conflict of interest exists if an employee has a private interest that could influence, or reasonably be seen to influence, how they perform their public duties. The conflict can be actual, potential or perceived. The private interest can be financial or non-financial, direct or indirect.

**What are organizational conflict of interest policies?** An organizational conflict of interest (OCI) can exist when a company assists the federal government in developing the specifications for a product or service and then competes for a contract to provide that product or service. A similar situation can arise at universities.

**Why is it important to have a conflict of interest policy?** Your Conflict of Interest Policy should be written specifically with your business needs in mind. Not only should it set out your business' expectations, but also clearly outline what types of activities and behaviours are not allowed. Getting it right is important to protecting your business' interests.

**What are conflict of interest policies designed to?** Conflict of interest policies are designed to reduce incentives that can lead to biased research results and to preserve the public trust, said Pierce.

**What is an example of a conflict of interest policy?** Example 1: An organization purchases insurance coverage through a firm owned by a board member. This would constitute a conflict of interest. Even though insurance purchases might normally be a CFO's or business administrator's function, a transaction with a board member must always be approved by the board.

**What is an example of a management conflict of interest?** Examples of Conflicts of Interest Gift issuance is also a very common conflict of interest. It happens when a corporate manager or officer accepts a gift from a client or a similar type of person. Companies normally circumvent this issue by prohibiting gifts from customers to individual employees.

**What are the requirements for a conflict of interest policy?** What should a conflicts of interest policy include? A policy on conflicts of interest should (a) require those with a conflict (or who think they may have a conflict) to disclose the conflict/potential conflict, and (b) prohibit interested board members from voting on any matter in which there is a conflict.

**Why is it important to have a workplace conflict management policy?** Office conflict can lead to lower employee productivity (where gossip and tension becomes a waste of valuable time and energy), poor work attendance, low employee morale, and non-cooperation within the work team. It may even lead to resignations and costly reappointments.

**What is organizational conflict of interest policy?** An Organizational Conflict of Interest (OCOI) may result when factors create an actual or potential conflict of

interest on an instant contract, or when the nature of the work to be performed on the instant contract creates an actual or potential conflict of interest on a future acquisition.

**What is a conflict of interest management plan?** Conflict of interest management plans are written documents or statements that enhance transparency and create separation between an employee's personal activities and his/her university work in order to avoid the appearance of impropriety in university decision-making or research.

**What qualifies as a conflict of interest?** What is a Conflict of Interest? A conflict of interest occurs when an individual's personal interests – family, friendships, financial, or social factors – could compromise his or her judgment, decisions, or actions in the workplace. Government agencies take conflicts of interest so seriously that they are regulated.
