Gewiß weiß heute jeder, daß etwa französisches oder englisches Recht zu anderen Ergebnissen kommen kann, als wenn man nur seine Haupttermini von einer Sprache in die andere übersetzt und daraus Schlüsse ziehen würde: Die Systeme weichen voneinander ab; sie sind aus älteren ableitbar und münden letztlich im römischen Recht samt dem kanonischen Zweig. Und schon das altgriechische war anders.

Auch Altägypten hat sein Rechtssystem und in Mesopotamien ist es wieder anders. Weshalb ist es verschieden geworden? Woraus ist ein Rechtssystem erwachsen? Und wo liegt sein Anfang? Für viele sind diese Fragen gänzlich neu; denn Rechtsgeschichte ist ein eigenes Fach, das sich aus seinen Spezialisierungen auch erst zu einem Überblick entwickeln musste.

Diese Arbeit, der begrenzte Teil einer größeren, die an "Fragen zum altägyptischen Recht der Isolationsperiode vor dem Neuen Reich", Utz-Verlag München 1999 anschließt, versucht dabei auch zu dem dort im Vorwort genannten Projekt LAMPE/RIES von 1999 das Anliegen LAMPEs, die Frage nach der "Evolutionstrias" von Evolution – Selektion – Stabilisierung in Kapitel 8 § 16.5 noch mit einzubringen.

Anstatt "aktuell" auf die jüngste Literatur einzugehen, erscheint es einleitend wichtiger, im ganzen bisherigen Zusammenspiel der Forschungsgeschichte zum Alten Ägypten den eigentlichen Ort einer Rechtsgeschichte zu entdecken; denn auch das Nichterreichte kann dabei lehrhaft sein, wie alle Ansätze zu einer solchen.

Bei einem ägyptologischen weithin unbekannten "Rechtssystem" im Mittelpunkt moderner Analyse ist es zweckmäßig, erst auf Methode und Kausalität der ganz eigenständigen ägyptischen Anfangsentwicklung das Schwergewicht zu legen, an welcher ja Religion und Staatsaufbau auch teilhaben – ausgehend von der Dynamik des Königtums, wodurch aber die Analyse der wachsenden Gesellschaftsbasis noch zurückstehen muß, wie auch die des veränderten Weltbildes im Neuen Reich.

Enterprise electronic medical records (EMR) have largely become a standard since their use was mandated by The American Recovery and Reinvestment Act of 2009. However, perfusion departments have adopted true perfusion EMRs at various rates. Most deaths in HIV-infected patients receiving antiretroviral therapy are now related to conditions other than AIDS. HIV infection appears to increase the risk of many non-AIDS-related conditions, highlighting the importance of preventive care, however, recommended health maintenance items unique patients with HIV (PWH) are not always accomplished. We aimed to improve health maintenance by implementing a SmartPhrase and a Care Gap package in the EPIC Electronic Medical Record (EMR).

We developed a HIV health maintenance SmartPhrase in EPIC that included the last screening dates for syphilis, gonorrhea, chlamydia, hepatitis A, hepatitis B, hepatitis C, latent tuberculosis, hyperlipidemia, diabetes and human papilloma virus and the dates of receipt of hepatitis A vaccines, hepatitis B vaccines, pneumococcal conjugate vaccines, pneumococcal polysaccharide vaccines and influenza vaccines (Figure 1). Providers can select their plan for each health maintenance item based on these data and their plans are documented in the encounter notes. Providers were educated to use the SmartPhrase in each office visit. An HIV registry was built after choosing 509 HIV related medical conditions. The health maintenance topics were displayed in a "Care Gaps" summary using the data in the HIV registry (Figure 2). Completion rates for the health maintenance items were compared before and after implementation. The health maintenance package was implemented on 3/1/2020.

CD4 every 6 months is displayed as a part of the health maintenance in a "Care Gaps" summary using the data in the HIV registry, whether their HIV is well controlled or not.

Of the 380 patients in the registry, 162 had office visits with the ID clinic from 1/1/20 to 6/5/20. Chart review of 100 patients who had office visits after implementation was performed and compared to the 62 patients prior to implementation (Table 1). The rates of hepatitis A vaccination (P= 0.001), hepatitis B vaccination (P= 0.05) and influenza vaccination (P=0.035) were increased significantly. Pneumonia vaccine administrations and anal pap smear performance compliance remained suboptimal. Providers reported that the time they spent searching for lab results and immunization records and documenting were shortened.

The rates of hepatitis A vaccination (P=0.001), hepatitis B vaccination (P=0.05) and influenza vaccination (P=0.035) were increased significantly.

A health maintenance package consisting of a SmartPhrase and summary display in the EMR with provider education likely helps improve health maintenance in PWH.

What novel did Steinbeck win the Pulitzer Prize for? On May 6, 1940, John Steinbeck is awarded the Pulitzer Prize for his novel The Grapes of Wrath.

What is John Steinbeck famous for? John Steinbeck (born February 27, 1902, Salinas, California, U.S.—died December 20, 1968, New York, New York) was an American novelist, best known for The Grapes of Wrath (1939), which summed up the bitterness of the Great Depression decade and aroused widespread sympathy for the plight of migratory farmworkers.

This Depression-era tragic tale that was praised for its realism is regularly found in the top one hundred of the banned book list published by the American Library Association because of racial slurs, profanity, vulgarity, and offensive language.

Why was Animal Farm banned in the US? There are many places in the world where George Orwell's satire Animal Farm has been banned. To say that the United States is not one of these places is an understatement. The book was misunderstood and was seen as being critical of all forms of socialism, rather than specifically Stalinist communism.

What is the paradox in Grapes of Wrath? Paradox is used to describe the wealth and poverty that co-exist in California, the heavy cost of freedom, the destruction of food while people are starving, and Pa's increase in body odor since he started bathing more regularly.

Did John Steinbeck marry and have children? In 1942, after his divorce from Carol, Steinbeck married Gwyndolyn "Gwyn" Conger. With his second wife Steinbeck had two sons, Thomas ("Thom") Myles Steinbeck (1944–2016) and John Steinbeck IV (1946–1991).

Did Steinbeck win Nobel? John Steinbeck's "realistic and imaginative writing, combining as it does sympathetic humor and keen social perception" earns the

Salinas native the 1962 Nobel Prize for Literature, awarded on October 25.

What was Steinbeck's first novel? Steinbeck attended Stanford, but in 1925 he left the university to launch a writing career. Cup of Gold, his first novel, was published in 1929. His next three novels, all set in California, earned him increasing acclaim, but it was not until The Grapes of Wrath (1939) that he became nationally known.

Which John Steinbeck to read first? If you are new to reading books by John Steinbeck, a great place to start is his classic novel Of Mice and Men. This novella follows the story of two migrant workers—George and Lennie—as they search for their own piece of the American Dream during The Great Depression.

What's better, East of Eden or Grapes of Wrath? If you're definitely going to read both then maybe start with Grapes of Wrath and then continue on with East of Eden. Both are excellent novels, but East of Eden is a little better.

What was John Steinbeck's style? He considered his work to be experimental. He intentionally used a documentary style for The Grapes of Wrath, the fabular for The Pearl, the picaresque for Tortilla Flat, and so on. Generally he belongs to the myth-symbol school of the twenties.
