The four types of evolution are divergent evolution, convergent evolution, parallel evolution, and coevolution. Divergent evolution occurs when a single species branches off into more than one. What engine is in a Ford 4000 tractor? In the first three years of the Ford 4000's production, it was almost identical to the 801 and 901 series and was equipped with 2.8-litre, four-cylinder Ford engines that are available in gasoline, diesel, or LP gas and have a 64-litre fuel tank.

How to tell what year a Ford 4000 tractor is? To determine this, look at the tractor production code, also known as the unit date code.
