William Littell was known for his great scholarship, literary competence, and publishing experience. Nearly a dozen imprints bearing Littell's name have been published, including a set of Kentucky statutes that were the state's de facto code for decades, Kentucky's first historical monograph, law reports, and a book of satire. Littell was a curious figure. He almost single-handedly created the infrastructure of legal research in the state. Outside of the law, he wrote history, poetry, and political satire and was learned in theology and medicine. But Littell was a solitary, eccentric figure; disliked by many; and politically and socially neutralized by his uncompromising pen, which skewered slave owners, abusive husbands, bankers, and politicians.

Dove sono conservati i nominativi degli associati? Il libro dei soci è uno dei registri che l'ente associativo deve conservare presso la propria sede legale. In tale registro vengono annotati i nominativi e i dati di tutti i soggetti regolarmente iscritti all'associazione.

Come si tiene la contabilità di un'associazione? La prima accortezza sarà la tenuta di un registro inventario, dove elencare tutti i beni dell'associazione o dell'ente. However, not all are poised to benefit from such developments, as big divides emerge. Over 80% of high-impact neuroscience publications are produced by only 10 countries, while 70% of countries contributed fewer than 10 such papers over the period considered. Similarly, six countries only hold 87% of IP5 neurotech patents. This report targets policy makers, researchers, patent analysts, scientists, technology enthusiasts, ethicists, and anyone interested in the intersection of neuroscience, technology, and society. This report sheds light on the neurotechnology ecosystem, that is, what is being developed, where and by whom, and informs about how neurotechnology interacts with other technological trajectories, especially Artificial Intelligence. The report underscores the need for evidence in support of policy making and calls for the ethical governance of neurotechnology, to ensure that its development and deployment respects human rights, fundamental freedoms and human dignity, safeguarding individuals and societies.
