Religious studies as an academic pursuit is heir to the ideal of objectivity traditionally pursued in the social sciences. On September 30th of 2005 the *Jyllands-Posten*, a Danish newspaper, published twelve cartoons of the Muslim prophet Muhammad. Islamic law forbids all depictions of Muhammad because they are idolatrous, and the fact that these cartoons were perceived as disrespectful intensified the offence. Many Danish Muslims felt that these illustrations were inappropriate, even discriminatory; people staged protests and demanded apologies, and Muslim organizations condemned the *Jyllands-Posten*. Regardless, the cartoons – and other, even more insulting ones – quickly spread. Newspapers in dozens of countries reprinted the offending cartoons, and the speed of internet communications meant that the illustrations were available for viewing by anyone. As more and more countries became involved, protests escalated to riots and people on both sides of the controversy were killed.

Therefore, in order to appropriately understand the Hebrew Bible, the fallibility of translation must be recognized.

Mack viewed these textual representations as "identity markers" by which groups of early Christians defined themselves in the hectic social economies of the Hellenistic world. In this way, he helped establish a distinctly North American style of biblical studies, which many now designate as the study of "Christian origins," in contradistinction to the more traditional field of "New Testament studies."

What is a nonlinear ordinary differential equation? A nonlinear differential equation is an equation of the form $x_{n+1} = f(x_n, x_{n-1}, \dots)$ where x_n is the value of x in generation n and where the recursion function f depends on nonlinear combinations of its arguments (f may involve quadratics, exponentials, reciprocals, or powers of the x_n 's, and so forth).

Is Introduction to Ordinary Differential Equations hard? In general, solving an ODE is more complicated than simple integration. Even so, the basic principle is always integration, as we need to go from derivative to function. Usually, the difficult part is determining what integration we need to do.

Why are nonlinear differential equations hard to solve? Examples of nonlinear differential equations are the Navier–Stokes equations in fluid dynamics and the Lotka–Volterra equations in biology. One of the greatest difficulties of nonlinear problems is that it is not generally possible to combine known solutions into new solutions.

How to tell if a differential equation is non-linear? (1) the dependent variable (y) and all its derivatives in the equation are of power one. are either constants or depend only on the independent variable (x). If any one of these 2 conditions is not satisfied, then the DE is said to be nonlinear DE.
