As the United States moves to become less energy dependent on foreign sources, the importance of production from domestic stripper oil and gas wells will be much greater than it is today. Currently, stripper oil wells account for 15 percent of total domestic oil production and stripper gas wells account for 8 percent of total dry gas production. The importance of stripper wells is also reflected in that they represent 77 percent and 63 percent of the country's total oil and gas well populations respectively. Therefore, developing inexpensive technologies will be key in keeping these wells productive and helping the nation meet its energy demand.

In an effort to help maintain the production from stripper wells, the Department of Energy provides funding to the Stripper Well Consortium (SWC) to develop and demonstrate technologies that will improve the production performance of stripper wells. The SWC was established in 2000 and has cofunded over 60 projects since its inception. The SWC is an industry-driven organization and all projects are selected by a seven-member Executive Council elected for member organizations. Several projects have been completed and are now being offered commercially. This paper will focus on the operation of and the opportunities offered by the SWC, as well as highlighting a few of the successful projects such as the Gas Operated Automatic Lift (GOAL) PetroPump, the Vortex flow tools, the hydraulic diaphragm electrical submersible pump, and the new novel Weatherbee pump/compressor.

**What is a 501c3 form pdf?** The 501(c)(3) application PDF refers to the application form required by the Internal Revenue Service (IRS) in the United States for an organization to be recognized as a tax-exempt nonprofit organization under section 501(c)(3) of the Internal Revenue Code.

**Does a church need to file Form 1023?** Churches are not technically required to file Form 1023 to be considered a tax-exempt organization. However, by filing Form 1023, churches can obtain a Determination Letter from the IRS that is considered proof that the church is a 501(c)(3) tax-exempt organization.

**How long does it take to get 501c3 approval?** Approval can take 3 months to a year. If your application was postmarked after the dates listed, it has not yet been assigned to a specialist. In such cases, keep checking the IRS website for updates and await IRS contact. There's no need to make inquiries by phone.

**What is the IRS form for 501c3?** To apply for recognition by the IRS of exempt status under IRC Section 501(c)(3), you must use either Form 1023 or Form 1023-EZ. All organizations seeking exemption under IRC Section 501(c)(3) can use Form 1023, but certain small organizations can apply using the shorter Form 1023-EZ.

**How many pages is the 501c3 application?** IRS Form 1023 is 29 pages long, plus additional required schedules and attachments. While not all organizations have to complete every page, a typical application package is between 50-100 pages of material.

**What is the correct way to write 501c3?** Organizations described in section 501(c)(3) are commonly referred to as charitable organizations. Organizations described in section 501(c)(3), other than testing for public safety organizations, are eligible to receive tax-deductible contributions in accordance with Code section 170.

**Is a church automatically a 501c3?** Churches (including integrated auxiliaries and conventions or associations of churches) that meet the requirements of section 501(c)(3) of the Internal Revenue Code are automatically considered tax exempt and are not required to apply for and obtain recognition of exempt status from the IRS.

**What are the disadvantages of a 501c3 church?** Disadvantages of 501c3 for Churches Those include: No private ownership: Nonprofit organizations are publicly

owned, which means that 501c3 churches cannot be sold like a business or transferred to private individuals by their founders.

**What is the difference between a 501c3 and a 1023?** A 501(c)(3) and 1023 are not the same things, but rather complementary of one another. Section 501(c)(3) is part of the Internal Revenue Code that describes how to become tax-exempt status and Form 1023 must be filed in order to achieve that status.

**Is it hard to get 501c3 status?** In order to become a tax-exempt nonprofit, one must file for tax-exempt status. This is a difficult process and professional help is often recommended. The most common way to become a tax-exempt nonprofit is by establishing the organization as a section 501(c)(3) entity with the IRS.

**Can a 501c3 application be denied?** On the other hand, a denial by the IRS of 501(c)(3) status, known as an adverse determination, is a very difficult situation.

**Can I fundraise while waiting on 501c3 status?** Do you need a 501(c)3 to receive donations? No, you can continue receive to donations without having yet filed your 501(c)3 application. However, without a 501(c)3 status, your donors will not be able to receive a tax deduction for their donations.

**How much does the IRS charge for a 501c3?** The fee is \$600 (as of 2021) regardless of what income your organization projects. Be sure that your paperwork is filled out correctly, as the fee is nonrefundable. If you're hoping to find a 501(c)(3) fee waiver, don't waste your time.

**What is the difference between a nonprofit and a 501c3?** While a nonprofit corporation is a state-level designation, the 501(c)(3) status is a federal, nationwide designation awarded by the IRS. If a group has 501(c)(3) status, then it is exempt from federal income tax, which often also means you don't need to pay state income taxes either.

**How do I start a 501c3 for dummies?**

**What is the 27 month rule for 501c3?** In general, an organization must file its exemption application within 27 months from the end of the month in which it was formed. If it does so, it may be recognized as exempt back to the date of formation.

**How often should a 501c3 be audited?** 496.407 requires audits for charitable organizations as follows: For those receiving annual contributions of \$1 million or more an independent audit is required; for those with annual contributions of at least \$500,000 but less than \$1 million, the financial statements may be reviewed or audited by an independent CPA, ...

**How do you know when your 501c3 is approved?** After you submit your application If you submitted your application before the date indicated in the chart on that page and haven't been contacted, you can call the toll-free Customer Account Services number at 877-829-5500 Monday through Friday, 8 a.m. - 5p.m. (local time), to check on the status.

**How difficult is it to create a 501c3?** The disadvantages of establishing a 501(c)(3) include the time and expenses involved, limited personal control over the organization's direction, financial scrutiny by the IRS, a lot of paperwork at startup (and annually thereafter) and regulations and restrictions surrounding the work in which the nonprofit can be ...

**Does a 501c3 need a CEO?** Whether an organization requires a CEO or an Executive Director to lead their organization often depends on the culture of the nonprofit Board, and if they themselves are setting the full mission, vision, values, and strategy for the organization.

**How do you structure a 501c3?** The five steps to becoming a 501(c)(3) corporation are: choose a purpose, form a corporation, file paperwork with the IRS, comply with state and local requirements, and maintain your nonprofit status. Becoming a nonprofit means you are exempt from certain tax requirements that apply to other types of businesses.

**What is a 501c3 document?** Section 501(c)(3) is the portion of the US Internal Revenue Code that allows for federal tax exemption of nonprofit organizations that meet the code's requirements. These nonprofits may be considered public charities, private foundations, or private operating foundations, which we'll explain in more detail later.

**What is the purpose of a 501c3?** The exempt purposes set forth in section 501(c)(3) are charitable, religious, educational, scientific, literary, testing for public safety, fostering national or international amateur sports competition, and preventing cruelty to children or animals.

**What's the difference between a non profit and a 501c3?** Actually, no! These terms are often used interchangeably, but they all mean different things. Nonprofit means the entity, usually a corporation, is organized for a nonprofit purpose. 501(c)(3) means a nonprofit organization that has been recognized by the IRS as being tax-exempt by virtue of its charitable programs.

**How do I get a copy of my 501c3 form?** Requesting Copies Older organizations can request a copy of the determination letter by submitting Form 4506-A to the IRS. Alternatively, you can request an affirmation letter, which will confirm that your nonprofit is tax-exempt as of the date of the request.
