# PADRES CRIANDO NINOS CON PROBLEMAS DE SALUD Y NECESIDADES ESPECIALES

Evaluación de necesidades de salud para servicios basados en el acompañamiento psicosocial a padres con hijos con compromiso vital en unidad de cuidados intensivos pediátricos.. Psicogente. Objetivo: identificar cuáles fueron, desde el punto de vista de las madres y padres, las condiciones de estudio, los aprendizajes y las reacciones emocionales antes y durante la pandemia de sus hijas/os con necesidades educativas especiales, además de conocer algunas condiciones emocionales de ellas/os mismas/os. Método: Se realizó un estudio exploratorio, en el cual se aplicaron cuestionarios digitales a madres y padres de alumnas/os con y sin necesidades educativas especiales, seleccionados mediante un muestreo no probabilístico, intencional. Participaron 2.634 madres y padres (entre 35 y 38 años de edad en promedio, 90 % mujeres). Resultados: Se encontró que los alumnos estudiaron en condiciones precarias, y se vieron afectados seriamente en sus aprendizajes y mostraron reacciones emocionales negativas durante la pandemia. Los alumnos con necesidades educativas especiales resultaron muy afectados, pero no mucho más que los alumnos sin estas necesidades, lo cual probablemente se debió al trabajo de las USAER. Las madres y padres, particularmente de los alumnos con NEE, presentaron cansancio y frustración. Conclusiones: Se concluye que el confinamiento produjo serias afectaciones en todos los estudiantes, incluyendo a quienes presentan necesidades educativas especiales, pero estos no resultaron mucho más afectados gracias al apoyo brindado por las USAER. Los Centros de Desarrollo Infantil (CDI), espacio donde se desarrolló la investigación, son aquellos donde se realiza el diagnóstico temprano y la atención integral individualizada, por un equipo multidisciplinario. Objetivos: Identificar la presencia de actividades relacionadas con la salud bucal en el programa de atención que desarrollan los especialistas; identificar las especialidades en las cuales se pueda incorporar la salud bucal y describir los elementos vinculados a la teoría de salud que manejan los especialistas. Materiales y métodos: estudio de campo; utilizando técnicas cuantitativas y cualitativas. Resultados: Los docentes realizan actividades de prevención, incorporando a las madres; orientan la instalación y el reforzamiento de los hábitos, incluyendo el cepillado dental (CDI1 el 50%, CDI2 62%); en ambos CDI los fisioterapistas y los terapistas ocupacionales incluyen a la boca en sus actividades, el terapista de lenguaje también la incluye en el caso del CDI2. En todas las especialidades de ambos centros se puede incluir la salud bucal en el programa de atención; los especialistas afirmaron la necesidad de incluir la misma dentro de sus rutinas (el CDI1 95%, CDI2 80%). The concept of hope has been identified as central to nursing and have gained visibility in the caring of children with special health needs and their families. With the emergence of new challenges in pediatric nursing and knowing the needs and adversities parents are facing in their daily life, interventions that promote hope should be highlighted. Objective: to map the interventions that have been implemented and evaluated to promote hope in parents of children with special health needs. Method: a scoping review was held, following Joanna Briggs Institute methodology, in the databases Pubmed, CINHAL complete and SciELO, in portuguese, english and spanish and in the time window from 2008 to 2018. Results: Seven studies were included in this review. The research that was found is mostly qualitative, dispersed in time and differentiated in terms of conceptual framework. Mostly evaluated in individuals, the studies encompass either group and individual interventions, with a large variability of contexts and intervention characteristics. Conclusion: discussions about hope promoting interventions in pediatric nursing care are currently occurring, the need for more research persists for the validation of hope promotion interventions in parents of children with special health needs.

El propósito de esta investigación es determinar el nivel de satisfacción de padres, madres y/o apoderados sobre el proceso de formación y atención de los estudiantes con "necesidades educativas especiales permanentes", integrados en 18 escuelas básicas municipales vulnerables de la ciudad de Arica. La muestra estuvo comprendida por 120 padres, madres y o apoderados de los estudiantes con necesidades educativas especiales permanentes. Se realizó un estudio exhaustivo de las cuatro dimensiones de gestión fundamentales en las direcciones de establecimientos educacionales: Gestión Institucional de la Integración, Gestión

Política y Normativa Vigente, Gestión Intra-aula y Gestión de Resultados. En el presente estudio fue adaptado de un instrumento de Autoevaluación de Centros Escolares para una Gestión de Calidad en México del año 2004. La encuesta consta de 52 enunciados, con una escala de valoración en la cual el 5 corresponde al valor más alto o positivo, el 1 al valor más bajo o negativo y la inclusión de un valor 0 relativo al desconocimiento de lo que se pregunta. Los resultados generales de esta investigación tienen bastantes aristas respecto a la gestión en integrar a los estudiantes y si existe efectivamente un nivel de 84,2 % de satisfacción de padres y madres y/o apoderados. Abstract The purpose of this research is to determine the level of satisfaction of parents, and / or parents over the process of training and care of students with "permanent special educational needs", integrated into 18 vulnerable municipal basic schools in the city of Arica. The sample was comprised of 120 parents, mothers and guardians of students with permanent special educational needs. An exhaustive study of the four main management dimensions in the management of educational establishments was carried out: Institutional Management of Integration, Political Management and Current Regulation, Intraclassroom Management and Results Management. In the present study, it was adapted from an Instrument for Self-evaluation of School Centers for Quality Management in Mexico in 2004. The survey consists of 52 statements, with a rating scale in which 5 corresponds to the highest or positive value, 1 to the lowest or negative value and the inclusion of a value 0 relative to the ignorance of what is being asked. ### FIDIC YELLOW BOOK

**CURRENT RESEARCH IN EGYPTOLOGY 2022** 

What is a FIDIC yellow book? The FIDIC Yellow Book outlines specific procedures for dispute resolution, including amicable settlement, mediation, adjudication, or arbitration. These mechanisms help resolve payment-related disputes and ensure timely resolution.

What is a red book and a yellow book? So one, the Yellow Book has a government perspective; Red Book has a multiple-industry perspective. One document's written by a member organization, the other by a government entity, which tends to be a little bit more rule-based.

What is the yellow book approach? The Yellow Book's mentality is rooted in facilitating seamless collaboration between employers and contractors in design-build projects. Design-build contracts involve a single entity, typically the contractor, taking on the responsibility for both the design and construction aspects of a project.

What is the difference between FIDIC red and FIDIC yellow? The best known of the FIDIC contracts are the Red Book (building and engineering works designed by the Employer) and the Yellow Book (M&E, building and engineering works designed by the Contractor). The original edition of the Red Book dates back to 1957.

What is FIDIC Golden Book? The Gold Book provides the conditions of contract for Design, Build, and Operate, including the general conditions, particular conditions guidance, and sample forms. It is for contracts combining design-build obligations with a long-term operation commitment.

**What FIDIC means?** FIDIC stands for 'Fédération Internationale des Ingénieurs - Conseils', which is best translated from French as The International Federation of Consulting Engineers.

What is a yellow book? Yellow Book: Government Auditing Standards Generally Accepted Government Auditing Standards (GAGAS), also known as the Yellow Book, provides the preeminent standards for government auditing.

Why is it called a yellow book? The Yellow Book was a literary and artistic periodical, which was published between 1894 - 1897. It supposedly took its name from the illicit French novels of the fin de siècle, which often dealt openly with sexual content. These novels were wrapped in yellow paper to alert readers to their

lascivious content.

What does the yellow book refer to? The set of telecommunications Recommendations, issued by the International Telecommunication Union Standardisation Sector in 1980, is referred to as the yellow book because of the color of their covers. This is to be contrasted with the red book (1984) and blue book (1988) versions of ITU-T Recommendations.

What is Yellow Book standard? In addition to financial audits, the Yellow Book standards cover Performance Audits, which evaluate the performance of a program or project against defined objectives, such as objectives for efficiency and effectiveness. The Yellow Book standards provide auditors with a framework for behaving ethically.

Who issues the Yellow Book? The U.S. Government Accountability Office (GAO) has issued the 2024 revision of Government Auditing Standards, also known as the Yellow Book.

Why is the Yellow Book important? Significance. The Yellow Book was a leading journal of the British 1890s; to some degree associated with aestheticism and decadence, the magazine contained a wide range of literary and artistic genres, poetry, short stories, essays, book illustrations, portraits, and reproductions of paintings.

What is FIDIC Yellow Book about? The FIDIC Yellow Book has introduced a provision in Clause 8 for early warnings, which was unseen in the original contract. Previously, an employer was only required to give notice and particulars of a claim to the contractor as soon as practical.

What is the role of engineer in FIDIC yellow book? FIDIC Contracts, although between The Owner and The Contractor, the parties signing the contract agreement, need The Engineer to be operated. The Engineer is the entity hired by the Owner, who administers and manages the Contract.

When to use FIDIC? FIDIC contracts are commonly used in international construction projects, and they are recognized and accepted worldwide. These contracts provide a standard set of terms and conditions that are fair and balanced for both parties.

Which country is FIDIC from? It was started in 1913 by the trio of France, Belgium and Switzerland. The United Kingdom joined the Federation in 1949. FIDIC is headquartered in Switzerland and now boasts of membership from over 60 different countries.

What are yellow book requirements? What are the Yellow Book CPE requirements? To maintain compliance with Yellow Book CPE requirements, auditors are required to complete 80 hours of CPE every two years. Of those 80 hours, a minimum of 20 hours should be completed in each year (meaning auditors shouldn't try to get all 80 hours in the same year).

What do you call the Yellow Book? The Yellow Book is the book of standards and guidance for auditors and audit organizations, outlining the characteristics of good audit reports, professional qualifications for auditors, and audit quality guidelines.

What is the difference between yellow book and blue book? Therefore, the Blue Book places expectations on evaluators that frequently mirror the expectations placed on auditors by the better known Yellow Book. whereas the Yellow Book places the follow-up burden on the entity to which the audit team addresses the recommendations.

What is the golden rule of the FIDIC? The Golden Principles are as follows: GP1: The duties, rights, obligations, roles and responsibilities of all the Contract Participants must be generally as implied in the General Conditions, and appropriate to the requirements of the project. GP2: The Particular Conditions must be drafted clearly and unambiguously.

What is the role of engineer in FIDIC yellow book? FIDIC Contracts, although between The Owner and The Contractor, the parties signing the contract agreement, need The Engineer to be operated. The Engineer is the entity hired by the Owner, who administers and manages the Contract.

What is the principle of FIDIC? The FIDIC Golden Principles uphold fair and sustainable policies in the client-contractor relationship: Balanced sharing of project risks – Risks should be allocated to the party best able to manage them. Excessive risk transfer leads to higher prices and disputes.

Who uses FIDIC? FIDIC, the International Federation of Consulting Engineers, is the global representative body for national associations of consulting engineers and

represents over one million engineering professionals and 40,000 firms in about 100 countries worldwide.

Why should I use FIDIC? FIDIC contracts do provide guidance on project specific sub-clauses where Particular Conditions might be used. Examples of non-project specific clauses (which should not be modified) include the following: 1. The role and authority of the Engineer (where applicable, otherwise the Employer's Representative):

What is FIDIC Yellow Book? The Yellow Book is a recommended design-and-build document for projects where the employer wishes to protect their interests. In this contract, the employer will appoint an engineer to supervise the overall construction of the works.

What is FIDIC function? FIDIC provides a framework for contracts and agreements used in construction and engineering projects, often referred to as "FIDIC Contracts." These contracts aim to establish fair terms, allocate risks, and ensure the smooth execution of projects between different parties involved in construction projects, such as ...

#### Which FIDIC book for design and build?

What is FIDIC Red book for? Significance of the FIDIC Red Book: The FIDIC Red Book serves as a valuable tool for standardizing construction contracts and ensuring fairness and clarity in contractual relationships.

What is the FIDIC pink book? What is the Pink Book? The Pink Book is the form of contract used by MDBs for construction projects (building and engineering works designed by the employer) for which MDBs are providing finance first published the contract in May 2005 and then published revised editions in March 2006 and June 2010.

What is the green book of the FIDIC contract? The Green Book is a short form of contract and is recommended for engineering and building works of a smaller scale. A maximum of USD\$500,000 and a six-month construction period was initially considered as a reasonable limit on the capital value and duration.

What is the FIDIC silver book used for? Hence the approach of the FIDIC Silver Book is for the EPC/turnkey contractor to create a single design liability wrap around the project, with the contractor being responsible both for the integration of the design and the construction of the works.

How many books are in FIDIC? There are five main types of FIDIC contracts: Red Book (construction), Yellow Book (plant and design-build), Silver Book (EPC/turnkey), Green Book (short form), and Pink Book (consulting services).

What is the difference between red and silver FIDIC? The Red Book has a balanced risk allocation between the Employer and Contractor compared to the Silver Book. Project administration is handled by the Engineer, who is appointed by the Employer.

# CHICKENHAWK BACK IN THE WORLD LIFE AFTER VIETNAM

**Is Chickenhawk a true story?** Chickenhawk is Robert Mason's narrative of his experiences as a "Huey" UH-1 Iroquois helicopter pilot during the Vietnam War.

What is chickenhawk about? The 1983 bestselling book Chickenhawk was a memoir by Robert Mason about his service in the Vietnam War, in which he was a helicopter pilot. Mason used the word as a compound oxymoron to describe both his fear of combat ("chicken") and his attraction to it ("hawk").

Who wrote the book "Chicken Hawk"? Robert C. Mason (born March 20, 1942) is a Vietnam War veteran and author of several books, including his first, best-selling memoir: Chickenhawk (1983).

**Do chicken hawks exist?** In the United States, chickenhawk or chicken hawk is an unofficial designation for three species of North American hawks in the family Accipitridae: Cooper's hawk (also called a quail hawk), the sharp-shinned hawk, and the Buteo species red-tailed hawk. The term "chicken hawk", however, is inaccurate.

What is chicken hawk slang for? A chickenhawk or chicken hawk is slang used in American and British gay culture to denote older males who prefer younger males for partners, who may less often be called "chickens", i.e., the prey of the chickenhawk. Other variations include chicken queen and chicken plucker.
