Penelitian ini bertujuan untuk mengetahui kebenaran pengaruh media musik remix terhadap minat siswa dalam materi senam ritmik pada pembelajaran Pendidikan jasmani SMAN 13 Depok. Penelitian ini dilakukan dengan menggunakan pendekatan kuantitatif dengan metode pra-eksperimen dengan one group pretest-posttest. Populasi dalam penelitian ini berjumlah 438 siswa dari 10 kelas. Dalam penelitian ini menggunakan teknik cluster random sampling, sampel yang digunakan dalam penelitian ini sebanyak 2 kelas, yaitu kelas XI IPS 3 dan XI MIPA 3 yang berjumlah 88 siswa. Instrumen yang digunakan dalam penelitian ini menggunakan kuisioner atau angket yang telah divalidasi. Terdapat tiga tahapan dalam penelitian ini, yaitu pretest, treatment, dan posttest. Rata-rata skor yang diperoleh dari pretest dan posttest masing-masing adalah 131.84 dan 134.84. Berdasarkan analisis statistik menggunakan SPSS 25.0, data pretest dan posttest normal didistribusikan dengan Sig. nilai lebih besar dari 0,05, pretest 0,078 > 0,05, posttest 0,062 > 0,05. Hasil uji homogenitas menunjukkan bahwa sig. nilai 0,670 > 0,05, sedangkan nilai pengambilan keputusan mengacu pada uji hipotesis menggunakan paired sample test dengan nilai sig (2-tailed) 0,014. Dari hasil penelitian ini dapat disimpulkan bahwa adanya pengaruh media musik remix terhadap minat siswa dalam materi senam ritmik pada pembelajaran Pendidikan jasmani SMAN 13 Depok.

Penelitian ini bertujuan untuk mengetahui peningkatan penguasaan teknik gerak dalam senam ritmik melalui senam kebugaran jasmani 2012 dalam pembelajaran penjas pada siswa kelas XII dengan menggunakan media pembelajaran audio visual di SMK Mitra Unggul Kabupaten Bekasi. Metode penelitian yang digunakan adalah penelitian tindakan (action research), dengan model desain Kemmis dan Taggart. Data secara keseluruhan berupa data kuantitatif dianalisis secara deskriptif terdapat peningkatan pada hasil belajar siswa dari siklus 1 ke siklus 2 berupa nilai tes hasil belajar antara lain: 1) Data pada prasiklus, skor rata-rata tes uji coba kemampuan teknik gerak senam ritmik melalui senam kebugaran jasmani 2012 dalam pada prasiklus yaitu 67,2 dengan prosentase 21,87% tuntas dan 78,13% belum tuntas, 2) Data pada siklus I, skor rata-rata tes teknik gerak senam ritmik melalui senam kebugaran jasmani 2012 pada siklus I yaitu 72,25 dengan prosentase 43,75% tuntas dan 56,25% belum tuntas, 3) Data pada siklus II, skor rata-rata tes uji coba kemampuan teknik gerak senam ritmik melalui senam kebugaran jasmani 2012 pada siklus 2 melalui dengan media audio visual yaitu 77,77 dengan prosentase 84,37% tuntas dan 15,62% belum tuntas.

Pembelajaran yang efektif sangat penting untuk keberhasilan pendidikan, terutama dalam pendidikan jasmani. Penelitian ini bertujuan untuk mengembangkan model pembelajaran senam ritmik yang lebih menarik bagi siswa sekolah menengah pertama di Kecamatan Karanganom, Kabupaten Klaten, Jawa Tengah, dengan menciptakan produk senam “Sahaja Renjana”. Metode yang digunakan dalam penelitian ini adalah penelitian dan pengembangan (R&D). Hasil uji coba skala besar menunjukkan bahwa aspek kognitif peserta didik memperoleh nilai rata-rata sebesar 63,75% (Cukup Baik), meskipun siswa cenderung bermain sendiri dan kurang memperhatikan saat praktik. Pada aspek afektif, siswa mencapai presentase 64,57% (Cukup Baik), menunjukkan bahwa senam sahaja renjana efektif dalam mengajarkan sikap kerjasama, kejujuran, tanggung jawab, dan sportifitas. Aspek psikomotorik menunjukkan presentase 68,4% (Cukup Baik), menandakan bahwa senam sahaja renjana diterima dengan baik oleh peserta didik. This research aims to determine the effect of the Blended Learning Model on Learning Outcomes in the New Normal Covid-19 Situation in Class VII Indonesian Language Subjects at MTs NW Sikur for the 2021/2022 Academic Year. The type of research used is Quasi Experimental. The population of this research is all class VII students at MTs NW Sikur for the 2021/2022 academic year. This research is population research because all members of the population in this study are the sample. Where class VII B is the experimental class while VII A is the control class. The research design used was Nonequivalent Control Group Design. The data collection technique used is a test. The data analysis used was the Polled Variance t-test analysis. The research results showed that the average learning outcome score for the experimental class was 71.2 and the control class was 69.4. To test the normality of the experimental class data, it was obtained that $X^2_{count} = 4.4521$ with $X^2_{table} = 11.07$, because $X^2_{count} < X^2_{table}$, meanwhile, the control class data normality test produced $X^2_{count} = 2.743$ with $X^2_{table} = 11.07$, because $X^2_{count} < X^2_{table}$, the data was normally distributed. The results of the hypothesis test show that $t_{count} > t_{table}$ is $3.913 > 2.942$, which means H_0 is rejected and H_a is accepted. So it can be concluded that "There is a significant influence using the Blended Learning Model on Learning Outcomes in the New Normal Covid-19 Situation in Class VII Indonesian Language Subjects at MTs NW Sikur for the 2020/2021 Academic Year."

Peristiwa penyebaran covid 19 yang merupakan eksponensial secara global yang menimbulkan dampak pada semua aspek kehidupan manusia, termasuk di dalam aspek pendidikan. Tujuan penelitian ini untuk mengetahui seberapa besar minat siswa kelas VIII dalam pembelajaran senam ritmik dengan menggunakan media musik irama melayu di SMP Negeri 1 Kedungwun. Jenis penelitian ini merupakan penelitian kuantitatif, yang menggunakan disain penelitian quasi experimental design. Populasinya adalah Siswa kelas VIII SMP Negeri 1 Kedungwuni, sampelnya berjumlah 59 siswa yang terdiri dari 28 siswa kelas VIII B dan 31 siswa kelas VIII H. Hasil penelitian ini diperoleh untuk kelas kontrol (VIII H) yang tidak diberikan perlakuan yaitu rata-rata hasil pretest (tes awal) sebesar 67,643 (49,87%) dan rata-rata hasil posttest sebesar 68 (50,13%) . Dimana dari data pretest ke posttest untuk kelas kontrol terdapat kenaikan yang kecil yaitu 0,26%. Sedangkan untuk kelas eksperimen yang diberikan perlakuan dengan media musik iringan melayu, diperoleh data hasil pretest (tes awal) sebesar 68,935 (48,59%) dan data hasil posttest (tes akhir) sebesar 72,935 (51,41%). Sehingga terjadi kenaikan minat siswa dari hasil pretest ke posttest sebesar 2,82%. Simpulan dari penelitian adalah, terdapat peningkatan minat pada siswa kelas eksperimen, peningkatan ini terlihat lebih signifikan dibandingkan dengan peningkatan pada kelas control. Saran dari penelitian ini adalah untuk guru penjas diharapkan dapat menerapkan berbagai model pembelajaran yang cocok untuk siswa.

The teachers are required to be able to adapt and develop their learning model in post-new normal condition at this time, the model should make the students understand the material being taught easier. In addition, teachers must also be able to apply face-to-face (traditional) and non-face-to-face (online) models. Therefore, to solve the problem, there is an appropriate learning model, namely blended learning. This article aims to examine in-depth thinking about the implementation of this learning model with the literature review method. Indeed, the blended learning model is a learning process that utilizes various approaches (i.e., media and technology) both offline and online. moreover, it can improve students' access in accessing learning materials, enhance their new experiences, improve the quality of learning, and reduce learning costs. As result, this article indicates that a theoretically blended learning model can be a learning model in post-new normal at the school and university, but further research is still needed to examine the effectiveness of blended learning implementation.

Advances in Information and Communication Technology provide tremendous benefits for the world of education. All can be easily done without any limits because each individual can do it himself. Such a broad impact has given a new color or face in the education system in this world. This is evidenced by the many developments of learning models that refer to information technology-based learning. For online learning, teachers use constructivist pedagogical strategies, this is chosen to make it easier for teachers to deliver learning which is considered very helpful because it includes interaction, collaboration, projects, problem-based. Our online learning process requires a cellphone and a data package to be able to convey and receive messages. Offline learning itself, the teacher conveys his learning using only 4 learning strategies which include guided discovery, discussion, demonstration and cooperative learning, this is done because of the limited time for offline learning.

Pengembangan media telah dilakukan penyempurnaan berdasarkan analisis data uji coba oleh ahli media, ahli desain media dan ahli isi/materi serta hasil uji coba sasaran, baik teman sejawat, uji kelas kecil dan kelas besar. Teknik pengumpulan data menggunakan angket/kuesioner dan dokumentasi. Skor ahli materi 92,30%; ahli media 91%; ahli desain 96,00%; uji coba teman sejawat 1 dan 2 skor 91,25%, kelompok kecil dengan skor 91,67% dan kelompok besar memperoleh skor 91,01%. Jika dijumlahkan secara keseluruhan adalah $553,23/6 = 92,20\%$. Maka kelayakan dari video pembelajaran sangat valid dengan rentang skor 85,01-100,00%. Sehingga video pembelajaran sangat layak untuk digunakan oleh siswa dan guru di sekolah. This article aims to review the potential of a Blended learning model implementation in Indonesian higher education institutions during the time of Covid-19. This conceptual paper attempts to explain the concept of Blended learning in terms of theory and practice, based on the literature discussed in several reputable international journals. Blended learning is defined as a learning model integrating face-to-face instruction with an online learning environment or e-learning. Initially, this model proposes to improve the deficiencies of a traditional learning model which is lack of technological resources, and at the same time to develop the gap of e-learning practice which is lack of a face-to-face learning experience. In the blended instruction, students will learn through face-to-face interaction in the classroom and supported by digital media such as a Website, Video, or Learning Management System (LMS). Meanwhile, the use of technologies is ordinarily applied for students' learning and peer-interaction outside of the class, especially for online discussion and homework submission. This method emphasizes that learning activity should not only occur in the classroom but also outside of the class through the digital device.

This research is based on the low learning motivation of students in learning rhythmic gymnastics movements. So that the impact on the low student learning outcomes with classical completeness 55.5%. Based on these problems, the solution chosen is to apply the Jigsaw cooperative learning model, because this learning model is a group learning model that can increase student activity. The formulation of the general problem of this research is whether the application of the Jigsaw type of cooperative learning model can improve the learning outcomes of rhythmic gymnastics for fifth grade students of SDN 3 Sukajawa. Whereas specifically, whether the Jigsaw type of cooperative learning model can improve teacher skills, student activities, and student learning outcomes in learning rhythmic gymnastics in fifth grade students of SDN 3 Sukajawa? The purpose of this study was to improve the quality of learning including teacher skills, student activities and learning outcomes of rhythmic gymnastics for fifth grade students of SDN 3 Sukajawa. This type of research is a classroom action research with two cycles. Each cycle consists of four stages, namely planning, implementing, observing, and reflecting. The research subjects were students of class V SDN 3 Sukajawa. Data collection techniques used knowledge tests, performance tests and attitude tests. The results showed that the skills of the first cycle teachers obtained an average score of 70 with

good criteria. In the second cycle obtained an average score of 80 with very good criteria. The level of knowledge of the first cycle students obtained an average score of 77.8 with good criteria. Cycle II increased with an average score of 82.4 with very good criteria. The results of student performance in the first cycle obtained an average score of 74.5 while the second cycle obtained an average score of 81.6. The students' attitude test in the first cycle obtained an average score of 76.5, while in the second cycle it obtained an average score of 81.5. The final score in cycle I obtained a score of 70 and in cycle II increased to 85. Completeness of classical learning cycle I was 72.2%, cycle II increased to 83.3%.

Do people know when they're dying? They Know They're Dying Dying is a natural process that the body has to work at. Just as a woman in labor knows a baby is coming, a dying person may instinctively know death is near. Even if your loved one doesn't discuss their death, they most likely know it is coming.

What is the most common symptom in the last 48 hours of death? They are likely to spend more time sleeping, and will often be drowsy even when they are awake. They may also drift in and out of consciousness. Some people become completely unconscious for periods of time before they die - this could be for a short period or as long as several days.

What is the most common symptom seen at the end of life? Often before death, people will lapse into an unconscious or coma-like state and become completely unresponsive. This is a very deep state of unconsciousness in which a person cannot be aroused, will not open their eyes, or will be unable to communicate or respond to touch.
